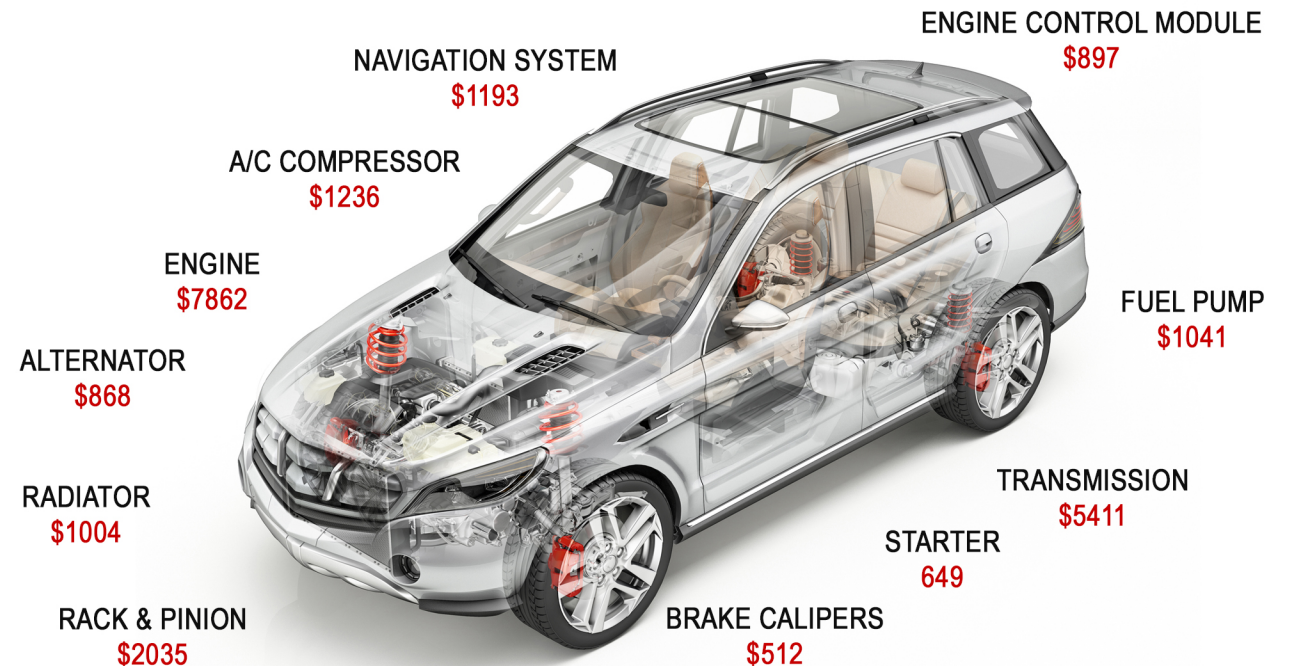

LEVEL 1 COVERAGE - POWERTRAIN COVERAGE

Vehicles newer than 11 years old, with 125,001 to 150,000 miles on the odometer at time of contract purchase, will qualify for this coverage only.

- 1. ENGINE:** Cylinder block, cylinder head and all internally lubricated parts; intake manifold, exhaust manifolds without internal catalytic converter; water pump, harmonic balancer and its bolt and pulley, valve covers, timing cover, timing belt and tensioner, timing chain, and gears; oil pump cover, gears, pressure relief valve, pickup and screen; oil pan, internal fasteners, engine mounts, flywheel, turbo/supercharger and waste gate; seals and gaskets for listed parts.
- 2. TRANSMISSION:** (Automatic or Standard) Transmission/transaxle case and all internally lubricated parts; extension housing, transfer case and all internally lubricated parts; torque converter, valve body, transmission pan, viscous coupler, shift linkage, bell housing, electronic shift control unit and solenoids; flex plate, ring gear, transmission mounts; seals and gaskets for listed parts.
- 3. DRIVE AXLE:** (Front and Rear) Differential housing and all internally lubricated parts; differential cover, front and rear wheel drive axle shafts; constant velocity joints and boots, universal joints, four wheel drive engagement actuator, four wheel drive locking hubs, drive shafts, center support and bearings; drive shaft yokes; seals and gaskets for listed parts.
- 4. ADDITIONAL HYBRID/PLUG-IN ELECTRIC COMPONENTS:** Electric motor/generator(s) and all internal components; inverter/converter/transformer units including all internal components; reduction/reducer box and all internal components; seals and gaskets.

LEVEL 2 COVERAGE - COMPONENT COVERAGE (INCLUDES ALL ITEMS IN LEVEL 1)

Vehicles newer than 11 years old, with 100,001 to 125,000 miles on the odometer at time of contract purchase, will qualify for this coverage only.

- 5. BRAKES (ABS AND NON ABS):** Master cylinder, wheel cylinders, vacuum and hydraulic brake boosters, metal hydraulic lines and fittings, calipers, backing plates and hardware, proportioning and combination valves, brake pedal assembly, electronic brake control unit, wheel speed sensors, pressure modulator control/isolation dump valves, high pressure hydraulic pump, solenoids, accumulator; seals and gaskets for listed parts.
- 6. AIR CONDITIONING:** Condenser, compressor, evaporator, expansion valve, orifice tube, clutch, coil and pulley, idler pulley and bearing; receiver dryer, o-rings, oil and refrigerant (when required with a covered repair due to leaks); manual climate control head, hi-low pressure cut off / cycling switch, A/C hoses and lines; seals and gaskets for listed parts.
- 7. STEERING:** Steering gear housing and internal parts; power steering pump, its internal parts and reservoir; rack and pinion housing and internal parts; power steering hoses, steering column shaft, couplings and bearings; pitman arm, idler arm, tie rod ends, center link; seals and gaskets for listed parts.
- 8. SUSPENSION:** Upper and lower control arms, shafts and bushings; stabilizer bars, bushings and links; torsion bars and their mounts and bushings, radius arms and bushings, strut bars and their links and bushings; spindle, spindle support and steering knuckle; ball joints; seals and gaskets for listed parts.
- 9. FUEL:** Fuel pump (mechanical or electrical), fuel pump relay, fuel distribution rails, fuel level sending unit, lift pump; seals and gaskets for listed parts.
- 10. ELECTRICAL:** Alternator, voltage regulator, starter motor and solenoid; power window motors and power door lock actuators; front and rear wiper motors; wiper motor relays and delay switch/module; washer pumps and switches; back up light switch, stop lamp switch, neutral safety switch, glove box light switch, courtesy light and door jamb switches, ignition switch, ignition lock cylinder and any electrical switch that is physically touched by a vehicle occupant to activate an accessory.

LEVEL 3 COVERAGE - EXCLUSIONARY COVERAGE (INCLUDES ALL ITEMS ABOVE - HIGHEST LEVEL OF COVERAGE)

Vehicles newer than 11 years old, with 0 to 100,000 miles on the odometer at time of contract purchase, will qualify for this coverage only.

We will pay or reimburse you for reasonable costs to repair or replace any breakdown of all parts listed in the Schedule of Coverage and any other parts, except for those items listed in the Exclusions from Coverage section of the contract. If you qualified for LEVEL 3, the components covered for LEVEL 2 and LEVEL 1 are covered, along with all other parts on the vehicle except those listed in the EXCLUSIONS section of the service contract.

POWERTRAIN BASIC COVERAGE (Limited High Mileage Coverage - \$5000 LIMIT OF LIABILITY)

Vehicles newer than 16 years old, with 150,001 to 200,000 miles on the odometer at time of contract purchase, as well as vehicles under 150,000 miles that are older than 11 years old and less than 16 years old, will qualify for this coverage only.

- 1. ENGINE:** Engine parts consisting of crankshaft & bearings, oil pump, oil pump pickup/screen and tube, pistons, piston rings, wrist pins, connecting rods & bearings, timing gears, timing chain/belt, timing tensioners/guides, balance shaft, camshaft, bearings, push rods, rocker arms/shaft, hydraulic lifters, intake and exhaust valves and springs, cylinder head gaskets. Engine block covered if mechanical failure was due to the failure of the above-listed parts.
- 2. TRANSMISSION:** Transmission/transaxle case and all internally lubricated parts; extension housing, transfer case and all internally lubricated parts; torque converter, valve body, viscous coupler, ring gear.
- 3. DRIVE AXLE:** Differential housing and all internally lubricated parts; differential cover, front and rear wheel drive axle shafts; constant velocity joints and boots, universal joints, four wheel drive engagement actuator, four wheel drive locking hubs, drive shafts, center support and bearings; drive shaft yokes.
- 4. ADDITIONAL HYBRID/PLUG-IN ELECTRIC COMPONENTS:** Electric motor/generator(s) and all internal components; inverter/converter/transformer units including all internal components and cover, continuously variable transmission and all internal components; power split device and all internal components; reduction/reducer box and all internal components.
- 5. SEALS AND GASKETS:** Seals and gaskets are only covered in conjunction with the repair of above-listed components.

OPTIONAL COVERAGES

Available on all coverage levels

TOTAL LOSS REFUND: (NOT AVAILABLE IN AL) \$50 If this option is selected, you will be refunded your full purchase price of this contract if your vehicle is deemed a total loss by your primary automobile insurance provider due to a collision or acts of God during the term of your contract. Maximum refund amount cannot exceed the purchase price of your contract, with a maximum limit of liability of \$2,000 or the current NADA loan value of your vehicle, whichever is less. Proof of total loss must be submitted to the Administrator with the cancellation request paperwork. (Not Available in AL)

LIFT KIT / TIRE MODIFICATION: \$600 The Lift Kit/Tire Modifications surcharge must be selected for the Vehicle to be covered if the Vehicle is equipped with oversized tires or body or suspension lifts including but not limited to leveling or lift kit, at the time of Vehicle purchase. The lift kit/tire modifications and all of their assemblies that are in addition to factory installed parts are excluded from coverage. The maximum increase for a body/suspension lift combined cannot exceed six (6) inches. The maximum tire height modification allowed is four (4) inches larger than the manufacturer specifications. Tires considered as aggressive off-road tires are specifically excluded. In order for the Vehicle to be eligible for coverage, the odometer must be recalibrated to reflect the true mileage due to the modification, and the cost of such recalibration is excluded from coverage. Any modification that voids the original manufacturer warranty will also void the coverage provided under this Contract.

COMMERCIAL USE: \$200 New/ \$350 Used (Used is any vehicle over 5 years old or over 50,000 miles) The Commercial Use surcharge is for vehicles intended for commercial use by a single driver during the execution of business or meets any of the following criteria: the vehicle is registered to a business, or has advertising signage permanently displayed on the exterior, or has commercial plates. (See contract for further exclusions).

SNOW PLOW: \$600 The Snow Plow surcharge must be selected for the vehicle to be covered if the vehicle is equipped with a snow plow at the time of vehicle purchase. The blade size must not exceed eight and one half (8.5) feet. The snow plow must meet the manufacturer's recommendations for the vehicle on which it is installed.

Included on Hybrid/EV Vehicles that are 5 Years Old or Less and with Less than 50,000 Miles at Time of Purchase

HYBRID/EV BATTERY PACK: \$500 The Hybrid/EV Battery Pack surcharge must be selected for your Vehicle to be covered. Rechargeable battery pack (comprised of many individual cells) for hybrid electric vehicle or electric vehicle including but not limited to, lithium-ion and nickel-metal-hydrate (NiMH) batteries. Standard 12V lead-acid batteries are excluded. Battery must be recharged regularly to ensure proper functioning. A Breakdown will be deemed to have occurred if the entire battery pack or individual battery cell(s) causes degradation to its ability to hold an adequate charge within the allowable capacity defined as the lesser of 70% or the manufacturer's capacity allowance. All other causes, except for Hybrid/EV battery Breakdown, due to normal usage and charging standards, are excluded. Hybrid/EV battery damage caused by improper charging including, but not limited to, overcharging or undercharging and/or malfunctions caused by charging stations. Hybrid/EV Battery Pack is limited to vehicles with a manufacturer installed Battery Thermal Management System. Vehicle must be current year model plus 5 years at the time of purchase and be within manufacturer warranty for battery coverage up to a maximum of 100,000 miles at the time of purchase. The Hybrid/EV Battery Pack total aggregate Limit of Liability is \$15,000 over the life of the contract.
